COVERAGE:

This TERO Vendor/Supplier License shall be limited to "covered employers" who do business, enter into contracts or projects directly involving the Three Affiliated Tribes, or to covered employers (agencies) who provide services to resident Indian of the FBIR. (This TERO License shall not conflict with the Business License issued by the Three Affiliated Tribes Legal Department.)
