2. Three Affiliated Tribes Tribal Employment Rights Office (TERO) Vendor/ Supplier License Fee **\$2,500.00**

HEREBY, _____ shall pay **\$2,500.00** Licensing fee, to perform the services listed on your application/ card, for the privileges to perform the service(s) on FBIR. Please be advised that services that are not listed but are displayed onsite will be subject to sanctions/ citations.

3. The following will apply to all firms, consultants, contractors, & subcontractors, working on or near the FBIR agrees to give first preference to all Certified Indian Contractors. (***Tero Ordinance- TITLE III. 301 Indian Preference in Contracting***)

COVERAGE:

4. This Tero Vendor/ Supplier license shall be limited to “covered employers” who do business, enter into contracts or projects directly involving the Three Affiliated Tribes, or to covered employers (agencies) who provides services to resident Indian of the FBIR. (*This Tero License shall not conflict with the Business License issued by the Three Affiliated Tribes Legal Department.*)
